



- 1) This trust shall be known as 'RURAL DEVELOPMENT ORGANISATION (Here after called RDO)
- 2) General objectives of the Trust is to provide, socio, Economic and Cultural advancement through Education, Training, Research and action for the upliftment of rural poor, tribal, slummers and other weaker sections.

- a) To conduct non-formal and formal educational programmes for removal of illiteracy and ignorance among socially, educationally and economically weaker section.
- b) To promote voluntary action by education and training among down trodden people to achieve socio-economic advancement with assistance of Government and non-government sectors:
- c) To provide training to youths on Leadership and community development for socio-economical transformation.


#### NOW THIS SUPPLEMENTARY DEED WITNESSETH

- c. Relief of the poor to give financial or other assistance in kind by way of distribution of books, notebooks, clothes, uniforms, or meals for the poor children and indigent.

# d. Other objects of general public utility particularly in child development and Women empowerment-

- To co-ordinate with government and other agencies to promote child development, child welfare, child protection and women empowerment by special kind of activities.
- ii. The activities of the trust will not be carried out outside of India.
- iii. To create awareness against Child sex abuse, Child labour, Child health etc.
- iv. To conserve our child environment and promote poor children education.

- xii. To eradicate of illiteracy, importing sound education for rural poor women.
